Keith Brunner then gave us an update concerning the TBOA meeting to be held in Memphis during the month of August. Keith Brunner will be the new president of the TBOA for the year of 2016.

### **New Business**

Danny again reminded everyone that applications for our Fall Conference, which is scheduled for September 11th and 12th in Gatlinburg, can be found on the UETBOA chapter web site. He encouraged everyone to register before August 15, since that is the cut-off date for the discounted room rates, and the cost of the classes also increase after that date as well.
