Motion for approval of the February 27, 2014 minutes was made by Keith Brunner and second by Tim Earles. The motion was passed by all present.

Treasurer report was given by the Secretary/Treasurer, Robert Montgomery; we have a balance of \$5,871.63 in the bank.

A motion for approval of the Treasurer's report was made by Tim Earles and second by Claude Smith. The motion was passed by all present.

Old Business

The scholarship committee was asked to report at our next month meeting regarding the winner of our local scholarship award. The deadline to submit

New Business

Jeff Woods, chairman, of the education committee reported on the Fall Conference scheduled to be held later this year in September. He said the hotel has been contacted and they only have September 11 and 12 open at this time. He also reported about the suggested charges and fees for the conference.

A motion was made by Tim Earles, to approve the suggestion of fees and charges for the UETBOA Conference to be held at the Glenstone Lodge in Gatlinburg, on September 11 and 12, 2014, and to have the ICC provide both days of training. A second was made by Dee Morgan. The motion was passed by all present.

A motion was made to approve sending in a deposit check in the amount of \$350.00 for the UETBOA Conference by Tim Earles and it was seconded by Dee Morgan. The motion was passed by all present.

Motion to approve the give-a-way of \$200.00 in (6) Lowes gift cards for the Fall Conference was made by Tim Earles and seconded by Travis Blevins. The motion was passed by all present.

There was a discussion about which class needed to be taught during the full day of training at the Fall Conference. It was narrowed down to Fire and Life Safety Principles or Fire and Smoke Protection. It was decided to first, see if an instructor was available for teaching either of these classes, on the first day. It is hoped that offering this type of training will prove to be helpful to our fire department membership. The other two, half day classes, will be scheduled to be held on the second day.

A motion to approve allowing the education committee chairman, Woods, to set up the training classes as necessary was made by Tim Earles and second by Joel Spencer. The motion was passed by all present.

Other Business

There were (17) seventeen members present.

There being no further business to discuss, the meeting was adjourned by President Danny Young.
